By engaging on TU Dublin SU's social media channels, you agree to these conditions and agree to avoid posting comments/content which contravene our conditions/guidelines. TU Dublin SU reserves the right to remove comments without notification which:

- Could reasonably be perceived as inappropriate, in poor taste, defamatory, discriminatory, obscene, demeaning, offensive, threatening, abusive, harassing or otherwise objectionable
- Promotes discrimination based on race, sex, religion, nationality, political belief, disability, sexual orientation or age
- Promotes or contains sexually explicit material or violence
- Are deemed to describe or encourage activities which could endanger the safety of others
- Discloses sensitive, private or confidential information about another person or enterprise or acknowledges intent to stalk an individual or collect private information without disclosure
- Appears to impersonate another person
- Contains spam or is deceptive for a commercial, vexatious or illegal purpose
